We are proposing to find alternative arrangements for the ownership and/or financial responsibility for each of the eight windmills owned by KCC, which would be a change to our current strategy for windmills as set out in the Kent Heritage Conservation Strategy. By seeking alternative ownership arrangements for all of the windmills, we would make an estimated saving of about £800,000 up until 2029. These changes are not expected to generate a large amount of income; the saving would be from the reduction of day-to-day running costs and maintenance of windmills.

### The Heritage Importance of the Windmills

All eight windmills owned by Kent County Council are listed buildings of exceptional significance. Six of them are listed Grade I or Grade II\*. Four are operating windmills and some of the others could be made operative. They form an important part of the industrial and social history of the County, as well as of the local areas in which they are situated. They are striking buildings in the landscape, in some cases iconic symbols of their town of village, frequently used to illustrate civic and tourism publications. They are not only of historical and architectural interest, but also assets of value to the community. All are open to the public and provide visitors with insights into and promote understanding of the history of local



agriculture and industry. The operating mills provide an immersive experience of a technology which supported the growth and development of our communities until the industrial revolution. A working windmill is a vibrant, almost 'living' thing. It is a three-dimensional demonstration of how the nation's essential 'staff of life' had been produced for a thousand years. It is very important that such structures that survive be preserved in public view.

#### Risks of a Potential Disposal of the Windmills

The windmills thus, collectively and individually, provide great public benefit. They are able to do so through the partnership between KCC and each volunteer group. KCC has the human and financial resources to care for, maintain and support the operation of the mills. It has built up the skills and experience to do over several decades. This is demonstrated by the successful programme of repairs to the windmills which KCC has undertaken in recent years. The volunteer groups provide the people on the ground to enable the windmills to open to the public, to engage with the local community and to deal with day-to-day administration of the windmills.

All these secure public benefits are put at risk by potential disposal of the windmills as contemplated in the Consultation Document, as is the structural condition and integrity of the windmills. Some of these risks are correctly identified in the Consultation Document. The volunteer groups have very limited resources, both financial and human. They lack the funds and, generally speaking, the management experience necessary for the care, maintenance and safe operation of each mill. Voluntary organisations generally are finding it increasingly hard to retain volunteers or recruit new volunteers and the windmill groups are unlikely to be unaffected by this established trend.

Having each windmill owned and operated by a separate, small charitable or other voluntary organisation would require replicating eight times over the cost of establishing such charities and the governance costs associated with them. Such charities would not have access to the economies of scale in obtaining the services needed to support the windmill operations, such as engineering, insurance, fire protection and regulatory compliance, which are available to KCC as the owner of a large estate of heritage assets, including the windmills.

Neither forming a charitable trust, nor registering a mill as an Asset of Community Value, would of itself provide access to additional funding for the mill. The trustees of a charity formed to acquire and operate a windmill would be ill-advised to proceed without a fully-costed business plan for the project and a substantial endowment to fund the majority of the



operating and future maintenance costs, as visitor revenue is unlikely to make more than a modest contribution to routine operating costs. There is no evidence that any such endowment would be provided, unless KCC were to provide it, which would defeat the financial objectives of disposing of the windmills. In the absence of such funding, it would in our view be irresponsible for KCC to proceed with any such disposal.

If KCC is unable to fund fully the uncompleted repair programme required for some of the windmills, then bringing in third party funding should be explored, as envisaged in the current Kent Heritage Conservation Strategy (Objective 8 on page 19). The Consultation Document does not indicate, nor are we aware, that any steps have been taken by KCC to explore alternative funding mechanisms. The Consultation Document suggests that local charities would have access to a wider range of funders than KCC itself. We anticipate, however, that third party funders would place greater confidence in the ongoing viability of the windmills in the secure ownership of KCC, than in the hands of small, underfunded and inadequately-resourced local charities.

We commend KCC for the care they have taken with these mills over the last 60 years. They are a community asset and as such it should be for the community to fund their upkeep. The existing ownership status is ideal in that maintenance is funded by residents in general as a miniscule proportion of council tax. We do recognise KCC's current financial situation, although we note press reports on 24<sup>th</sup> January that the government will provide substantial additional funding for Councils facing financial difficulties. However, the small annual cost of the windmills is negligible in the context of the Council's budget. If money is the only problem, then we would urge the Council to redouble their efforts to seek sources of funding from third parties and/or from diversification of use of their mills.

We would like to discuss with the Council what alternative funding packages might be possible, on a case by case basis. This will itself be an uphill struggle, as the alternative funding routes set out in Table 6 of the consultation demonstrate that there is no easy option. Further possibilities for consideration might include:

- sponsorship;
- renting out part of the premises;
- enabling development.



We would be pleased to meet KCC and the individual mill bodies to discuss this.

#### Issues that would arise in the event of a disposal

It is our considered view that KCC should retain ownership of the windmills. If, however, KCC were to attempt to dispose of any of the windmills, we suggest that the following considerations would arise. The Consultation Document strongly suggests that the eight windmills proposed to be sold, individually and together, have a negative value. They are financial liabilities. This massively reduces the prospective pool of purchasers if KCC were to pursue any attempt to sell them. There are very significant risks facing any alternative future owners. As the windmills are a drain on cash (both on a cyclical basis for major repairs and as a roughly level of annual operating costs) and profit cannot be made from them, prospective purchasers are likely to be:

- charitable organisations with access to substantial funds;
- businesses seeking prestigious heritage assets as loss-leaders; or
- wealthy private buyers able to bear the ongoing maintenance and other costs.

In our view, there will be very few, if any, such purchasers. They would all, sooner or later, seek to extract themselves from their liabilities, whether these be the terms of any KCC sale, listed building policy, planning policy, public access arrangements, or any other direct or indirect cost. The risks to the windmills sold, sooner or later (and probably sooner) would be immense.

Of particular concern to us is the prospect of the mills themselves being converted for residential use or, more likely, housing being developed within the curtilage, for example at the Davison Mill. Planning authorities may find it difficult to resist such proposals as it will doubtless be argued such development is necessary to secure the mill's future. The terms of sale, should a sale proceed, must state clearly whether such development will be allowed and if so under what conditions – conditions which should be legally binding for example by covenant. The conditions of sale should also include an obligation on the purchaser to continue the programme of repairs which KCC has identified as essential to their upkeep. Without this, KCC will be failing in its compliance with the existing objectives in its heritage strategy which it seems will remain in force (see below).

KCC acquired at least some of the windmills because it was clear that they remained



unsustainable as windmills in private ownership: KCC became the owner of last resort. Attempting to sell off the windmills would remove the safety net for their future existence as visual and operative entities. In all probability this would result in pressure for KCC to reacquire them at a future date. It would be irresponsible of KCC now to aim to sell the windmills knowing that in all probability these wonderful buildings will deteriorate and require KCC once again to intervene, by acquisition, to save them. It would not be good enough to 'take a chance' or to argue that 'this would be a problem for councillors in future rather than now'.

So we simply don't believe the sell-off would work. In the case of some windmills, like Meopham, no prospective purchaser could be expected to go near to acquisition, given the legal arrangements of KCC's current ownership.

#### **Amendment of the Kent Heritage Conservation Strategy**

The Consultation Document does not indicate what amendments would be made to the Kent Heritage Conservation Strategy in order to facilitate the potential disposal of the windmills. We trust, therefore, that should KCC decide, following the consultation, to proceed with attempting such disposals, a further consultation will take place on the wording of the proposed amendments.

If, after this consultation, a decision is taken to seek alternative arrangements for our windmills, we would explore whether existing local voluntary or community groups would be able to take on responsibility for ownership of the windmills.

For the reasons given above, we do not consider that such local groups have the resources to care for, maintain and safely operate the windmills and to open them to the public, nor have we seen any evidence that they could acquire such resources. The risks of disposal to a poorly funded and resourced local group are very great. It would take a very well thought out and funded proposal to convince us a mill would continue to be in safe hands. It is highly unlikely such would be forthcoming.



Finding alternative arrangements for the ownership and/or financial responsibility for our windmills would require a change to the Kent Heritage Conservation Strategy. Currently the strategy makes no mention of selling or transferring ownership of the windmills (see page 4 of the consultation document for what is currently included in the strategy).

If after this consultation a decision was taken to find alternative arrangements for our windmills, then a new objective would need to be added. The strategy would continue to set out how we would approach the management of the windmills we still own.

#### Who are we?

We, Kent County Council (KCC), take our privacy obligations seriously and we've created this privacy policy to explain how we treat your personal information collected in this questionnaire. Personal information is information we hold which is identifiable as being about you.

Our collection, use and disclosure of your personal information is regulated under the United Kingdom Data Protection Regulation and the Data Protection Act 2018. We are responsible as 'controller' of that personal information for the purposes of those laws. Our Data Protection Officer is Benjamin Watts.

## The personal information we collect and use

## Information collected by us

In the course of responding to consultations published by Kent County Council we collect the following personal information when you provide it to us:

- responses to questionnaire / consultation
- equalities data collected through questionnaire response age, sex, gender identity, ethnicity, religion or belief, sexuality, disability, pregnancy or maternity or if you are a Carer
- employment and education details
- postcode.

We ask you not to provide information that will identify you in your response in this questionnaire.

You do not need to submit any equalities or postcode information if you do not want to. KCC is committed to the principle that all our customers have the right to equality and fairness in the way they are treated and in the services that they receive. Any information you do give will be used to see if there are any differences in views for different groups of people, and to check if services are being delivered in a fair and reasonable way.

We will not ask you to provide your name, email or full home address. If you provide this information, it will not be entered into spreadsheets or databases used to process response data and will not be used in producing reports. We will follow our Data Protection policies to keep your information secure and confidential. Your equality data will be anonymised before it is shared with external organisations who have been



commissioned on individual projects to undertake analysis and reporting on our engagement and consultation activities.

## How we use your personal information

We collect and use this information in order to:

- understand your views about a particular topic or KCC activity
- · analyse consultation and engagement activity
- inform KCC's future strategy, policy, service design and budget planning
- undertake equality monitoring.

We may use your postcode to analyse the geographical spread of responses and in some cases to understand in more detail how responses are impacted by location. We will only ask you for the first five characters of your postcode to avoid being able to identify specific households in less populated areas.

We may use your postcode to carry out a type of profiling to estimate which one of a number of lifestyle groups you are most likely to fall into. We do this using geodemographic segmentation tools. We do not make any decisions about individual service users based solely on automated processing, including profiling.

## How long your personal data will be kept

We will hold any personal information provided by you in this questionnaire for up to six years following the closure of a consultation. Our Retention Policy is available from our website or on request.

We rely on UK GDPR Article 6(1)(e): 'processing is necessary for the performance of a task carried out in the public interest' and Article 6(1)(c) 'for compliance with a legal obligation to which the controller is subject' as our lawful basis.

We rely on Article 9(2)(g) 'processing is necessary for reasons of substantial public interest' (statutory etc. and government purposes, equality of opportunity or treatment) as the lawful basis on which we collect and use your special category data.

The processing is necessary for our statutory purposes including equalities monitoring or to understand the potential impact of proposals on conditions related to special category data within your response (e.g. when identifying or keeping under review the existence or absence of equality of opportunity or treatment between groups of people with the view to enabling such equality to be promoted or maintained.) It is necessary for identifying or keeping under review the existence or absence of equality of opportunity or treatment between groups of people with the view to enabling such equality to be promoted or maintained. ## Who we share your personal information with

We may share your personal data with those listed below:

- services within the council who are responsible for the management of the engagement or consultation activity
- a third-party supplier who has been contracted to independently analyse the consultation responses
- organisations such as schools and academies with whom we may be consulting in partnership or on behalf of
- district or borough councils or government departments with whom we may be consulting in partnership or on behalf of.

We will share personal information with law enforcement or other authorities if required by applicable law.

Any personal information provided that could identify you will be removed before consultation results are published.

We use a system to log your feedback, which is provided by Granicus.

## Your rights

Under UK GDPR you have a number of rights which you can access free of charge which allow you to:

- know what we are doing with your information and why we are doing it
- ask to see what information we hold about you
- ask us to correct any mistakes in the information we hold about you
- object to direct marketing
- make a complaint to the Information Commissioner's Office.

Depending on our reason for using your information you may also be entitled to:

- ask us to delete information we hold about you
- have your information transferred electronically to yourself or to another organisation
- object to decisions being made that significantly affect you
- object to how we are using your information
- stop us using your information in certain ways.

We will always seek to comply with your request, however, we may be required to hold or use your information to comply with legal duties.
